

1. ALL FOODS MUST BE REMOVED FROM THE HOME. ONLY UNOPENED CANS MAY REMAIN; ALL DAIRY PRODUCTS, FRESH FRUITS & VEGETABLES MUST BE REMOVED FROM THE HOME.
2. THE GAS LEAVES NO RESIDUE, SO ANY CRAWLING INSECTS MAY RE-ENTER THE HOME. NOTE: ANTS ARE COMMONLY DRAWN TO DEAD INSECTS. WE SUGGEST THAT YOU CONTACT YOUR PEST CONTROL SERVICE FOR IMMEDIATE RESIDUAL TREATMENT. IF YOU WISH, WE WILL BE HAPPY TO PEFORM THIS SERVICE FOR YOU.
3. ALL LIVING THINGS MUST BE REMOVED (PLANTS, ANIMALS, ETC.).
4. ALL GAS APPLIANCES, SUCH AS WATER HEATERS, STOVES/OVENS, ETC., MUST BE EXTINGUISHED AND THE GAS COMPANY IN YOUR AREA MUST COME TO RELIGHT PILOTS.
5. ALL BABY FURNITURE, SUCH AS CRIBS, PLAYPENS, CHANGING TABLES, ETC., MUST BE REMOVED IF THEY HAVE PLASTIC COVERINGS.
6. ALL CABINETS, DRAWERS, AND WINDOWS MUST BE OPENED AT LEAST A FEW INCHES (3-4 INCHES) IN ORDER TO ENSURE PROPER AERATION OF THE GAS. LIKewise, BLINDS MUST BE RAISED; ATTIC VENTS AND DRAPES MUST BE OPENED.

Important:

7. **ANY PLANTS AND/OR MULCH, CLOSER THAN 10-12 INCHES TO THE STRUCTURE MUST BE CUT/TRIMMED BACK OR REMOVED SO THAT THE TRAP CAN FALL FREELY AROUND THE STRUCTURE (BRANCHES/LIMBS OVER THE ROOF MUST BE REMOVED).**
ALL DECORATIVE STONES AND/OR MULCH MUST BE MOVED BACK AT LEAST 2 FEET FROM THE STRUCTURE. NOTE: SHRUBS AND PLANTS THAT ARE LOCATED ALONG THE SIDE OF THE STUCTURE SHOULD BE WATERED HEAVILY THE NIGHT BEFORE THE FUMIGATION; ALFA J. SERVICE TERMITE & PEST CONTROL WILL NOT BE RESPONSIBLE FOR ANY PLANT DAMAGE
8. DUE TO THE TYPE OF WORK INVOLVED, IT IS NECESSARY TO WORK ON ROOF AREAS. ALTHOUGH CAUTION WILL BE USED, ALFA J. SERVICE TERMITE & PEST CONTROL WILL NOT BE RESPONSIBLE FOR ANY CRACKED/BROKEN TILES OR DAMAGE TO ROOF, SOLAR HEATERS OR GUTTERS. MOBILE HOMES ARE SUBJECT TO THE AFOREMENTIONED CONDITIONS REGARDING ROOF AREAS. NOTE: IN ORDER TO ALLOW AN ADEQUATE DRYING PERIOD, TAR SHOULD NOT BE APPLIED TO ROOF DURING THE 2 WEEKS PRIOR TO FUMIGATION.
9. THE LAW REQUIRES THAT ALL BUILDINGS BE LOCKED DURING THE FUMIGATION. IT IS EXTREMELY IMPORTANT THAT ARRANGEMENTS ARE MADE FOR ALFA J. SERVICE TERMITE & PEST CONTROL TO HAVE ACCESS TO THE BUILDING DURING THIS TIME (OUR CERTIFIED OPERATORS WILL BE THE ONLY ONES ENTERNG THE STRUCTURE).

10. ALFA J. SERVICE TERMITE & PEST CONTROL WILL NOT BE RESPONSIBLE FOR VANDALISM, THEFT OR BREAKING AND ENTERING IN THE STRUCTURE THAT OCCURS DURING THE FUMIGATION AND AERATION PERIOD. IF THERE IS CONCERN, WE RECOMMEND A WATCHMAN OR GUARD BE HIRED FOR THIS PERIOD.
11. ALL AWNINGS MUST BE LOWERED; ALFA J. SERVICE TERMITE & PEST CONTROL WILL NOT BE RESPONSIBLE FOR AWNINGS.
12. WE WILL USE FANS DURING THE FUMIGATION AND WILL THEREFORE NEED ELECTRICITY.
13. GRASS THAT GROWS WITHIN 18 INCHES OF THE STRUCTURE MAY DIE AS A RESULT OF EXPOSURE TO GAS. THERE IS NO KNOWN STRATEGY TO PREVENT THIS FROM OCCURRING.
14. WHEN MASKING TAPE IS USED, WE WILL NOT ASSUME RESPONSIBILITY FOR ANY PAINT THAT LIFTS OFF AS THE TAPE IS REMOVED.
15. SCREEN ENCLOSURES WILL BE SEALED OFF IN SOME CASES. HOWEVER, IF THE DESIGN OR WEATHER DICTATES, THE SCREENS WILL NEED TO BE REMOVED BY THE HOME OWNER OR A PROFESSIONAL IN THE SCREENING INDUSTRY. REINSTALLING THE SCREENS IS THE HOME OWNER'S REponsibility.
16. DURING THE FUMIGATION, IT IS IMPERATIVE THAT ALFA J. SERVICE TERMITE & PEST CONTROL HAVE AN EMERGENCY PHONE NUMBER TO REACH THE OWNER OF THE STRUCTURE.
17. THE STRUCTURE WILL BE SECURED WITH A SECONDARY LOCKING SYSTEM. ALFA J. SERVICE TERMITE & PEST CONTROL WILL NOT BE RESPONSIBLE FOR ANY DAMAGE TO LOCKS IF INSERTS ARE REMOVED BEFORE FUMIGATION IS CLEARED.
18. SULFURYL FLUORIDE IS A COLORLESS, ODORLESS GAS WHICH CAUSES WATERY EYES AND SCRATCHY THROAT. A WARNING AGENT WILL BE ADDED TO THE BUILDING. IF ANY OF THE ABOVE SYMPTOMS ARE EXPERIENCED BY SOMEONE IN A STRUCTURE THAT HAS BEEN RECENTLY FUMIGATED, HE/SHE SHOULD LEAVE IMMEDIATELY AND CALL THE PEST CONTROL COMPANY TO HAVE THE BUILDING RETESTED.
